The Board of Trustees believes that regular school attendance contributes to successful student achievement. Furthermore, regular attendance is important because valuable skills and information gained in the classroom may or may not show up on tests or be reflected in an academic grade. It is the responsibility of the student and parent / legal guardian to meet the district and state attendance requirements.

The principal is responsible for implementation and enforcement of the student attendance policy. The following guidelines will be used to enforce this policy:

- 1. An accurate record system of student attendance shall be maintained by the school. The principal is responsible for submitting weekly attendance information to the superintendent or his/her designee.
- 2. A student is responsible for all work missed during any absence.
- 3. Parents will be notified either through a mailed letter or Skyward email when the student reaches five (5) and nine (9) excused or unexcused absences per semester. The letter shall indicate the attendance policy and the number of days missed. Parents may be asked to attend a conference with the principal or his/her designee to discuss excessive absences
- 4. Nine (9) unexcused absences and/or truancies will result in loss of high school credit for students in grades 9-12. Students who exceed the absences outlined in policy may appeal to the building principal.
- 5. Exceptions to the attendance procedure will be judged on his/her individual merit by the site administrator or designee.
